#### **BUSINESS OF THE MEETING**

- 2. To receive and consider the Reports of Officers.
- 3. To receive and consider the Financial Report, the Directors' Report and the Auditor's Report for the year ended 30<sup>th</sup> April 2025.
- 4. To appoint the Auditor for the Financial Year 2025/2026.

- 5. Election of the following Board positions, in accordance with Clause 29 of the Constitution of Gymea Miranda Bowling and Sports Club Limited:

  - □ Ordinary Director Clause 38 Vacancies on the Board
- 6. Declaration of Poll by the Returning Officer.
- 7. To consider and if thought fit to pass the following Resolutions:

### **Resolution 1**

That pursuant to the Registered Clubs Act, the members hereby approve the provision of refreshments to each Director during or immediately following each Board Meeting of the Club.

#### **Resolution 2**

That pursuant to the Registered Clubs Act, the members hereby approve and agree to expenditure not exceeding \$8,500.00 for the in kind remuneration through club food and beverage services of volunteers at the discretion of the Board of Directors.

## **Resolution 3**

That pursuant to the Registered Clubs Act, the members hereby approve and agree to expenditure for the reasonable costs of Board Members attending industry events, strategic planning sessions, professional development costs, uniforms where necessary, and other miscellaneous costs associated with executing their position on the Board of Directors, not exceeding \$10,000.00.

### **Resolution 4**

That pursuant to the Registered Clubs Act, the members hereby approve and agree to reasonable costs not exceeding \$3,000.00 for members of the Board of Directors and their partners to attend an annual Christmas Dinner hosted by the Chief Executive Officer.

8. To transact any other business which may be brought forward in conformity with the Constitution.

In accordance with the Club's constitution only Ordinary Members of the Club of the following classes who are financial at the date of the Meeting are eligible to vote on ordinary resolutions:

- Bowling Members
- Social V Members
- Social N Members
- Perpetual Members
- Life Members

In accordance with the Club's constitution only Members of the Club of the following classes who are financial at the date of the Meeting are eligible to vote on special resolutions:

- Bowling Members
- Perpetual Members
- Life Members

Clause 39.19 of the Club's constitution prohibits proxy voting at any General Meeting (including the Annual General Meeting) and at any election of the Board of Directors.

Please submit any questions regarding the Club's financial statements to the club's Chief Executive Officer not less than seven (7) days before the Meeting to allow time for the Club and its Auditor to give a suitably researched response.
